

CITY OF MORRIS - BILLING PROCEDURES

UTILITY BILLING INFORMATION

The City of Morris utility bill will include Water, Sewer, Water Testing Fees, Storm Water Administration Fees, Refuse and Waste Tax Fees. The bills are sent out every other month. East Side bills are sent in the even months – February, April, June, August, October and December. West Side bills are sent in the odd months – January, March, May, July, September and November. The bills are mailed on the 15th of the month or the closest business day after the 15th. Payments are due by the 5th of the month following the month in which the bill was sent (ie January 15th bill is due by February 5th). If the payment has not been received in our office on or by the due date, a 10% late fee will be applied to your account.

AUTOMATIC METER READING

The City of Morris is currently reading water meters by radio remote. This will be done 5-7 days before the bill is printed. The meter will be read from the outside of the house, so no access is required.
